Sir,

As Central Government by notification, constituted a Commission, to be known as the National Commission for Homoeopathy, to exercise the powers conferred upon, and to perform the functions assigned to it, as per NCH Act 2020 and its relevant regulations. As per provision in the Act, Medical Assessment and Rating Board for Homoeopathy has been constituted with the mandate to grant permission to the existing and new medical institution of Homoeopathy. Accordingly, it is to inform you that all the relevant documents submitted by your college in Part-1 Performa were examined by the Medical Assessment and Rating Board and the following shortfalls have been observed:

A. Miscellaneous:

- ESI is not deducted.
- Acquittance register is submitted without revenue stamps.


2. After considering the provisions of NCH Act, 2020 and its relevant regulations, **Permission of the Medical Assessment and Rating Board is issued to Shri Gujarati Samaj Shrimati Kamraben Raoji Bhai Patel Gujarati Homoeopathic Medical College Hospital, 1, Nasia Road, Education Complex Sch. No. 54, Vijay Nagar, Indore, Madhya Pradesh for conducting UG (BHMS) course with 100 seats for the academic year 2022-23.** The Principal is directed to fulfill the short comings within 30 days and an affidavit in this regard may be submitted to the Medical Assessment Board within a period of one week.

3. As per provisions of section 43 of the NCH Act, 2020 central Government has taken a policy decision vide letter no F.NO Y-11011/4/2022-EP-III Dated 14/10/2022 that all admissions shall be through NEET only with qualifying marks of 50 percentiles. All admissions in Under Graduate course shall be through NEET only. It is further informed that, minimum 15% of seats of the permitted intake capacity of UG (BHMS) course shall be treated as All India quota. The counseling for seats under All India quota shall be conducted by respective counseling Authority of State/UT Government as designated by the Central Government and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned counseling Authority of that State/UT. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Government for All India quota or the student admitted there under.

4. The category wise list of selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET qualified students will not be approved by the Medical Assessment and Rating Board as per rules. The College has to comply with the full requirements as per NCH Act, 2020 for conducting the course.

5. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Government for All India quota or the student admitted there under. The category wise list of students admitted may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed.


